COVID-19: PASSENGER RESTRICTIONS

E) ALL PASSENGERS, CREW MEMBERS AND OPERATIONAL STAFF ARRIVING TO BOSNIA AND HERZEGOVINA BY AIRCRAFT MUST COMPLETE A PUBLIC HEALTH PASSENGER LOCATOR FORM (PLF).

ALL PLFS MUST BE COLLECTED BY THE CREW, CHECKED AND HANDED OVER TO THE RAMP AGENT UPON LANDING.

- ALL AIRLINE OPERATORS ARRIVING IN BOSNIA AND HERZEGOVINA ARE REQUIRED TO INFORM THEIR PASSENGERS BEFORE BOARDING THE AIRCRAFT WITH FOLLOWING INFORMATION:
- IT IS TEMPORARY FORBIDDEN TO ENTER BOSNIA AND HERZEGOVINA TO FOREIGN NATIONALS. IN ACCORDANCE WITH THE LAW ON FOREIGNERS, THE DECISION ON REFUSAL OF ENTRY INTO BOSNIA AND HERZEGOVINA WILL BE DELIVERED TO ALL PASSENGERS.
- -THIS MEASURE IS NOT APPLICABLE TO THE AIRCRAFT CREW AND CABIN CREW WHOSE FINAL DESTINATION IS BOSNIA AND HERZEGOVINA.
- -THIS MEASURE IS NOT APPLICABLE TO DIPLOMATIC CONSULAR STAFF ACCREDITED (RESIDENT) IN BOSNIA AND HERZEGOVINA, WITH THE OBLIGATION TO COMPLY TO ALL INSTRUCTIONS AND ORDERS OF THE COMPETENT AUTHORITIES OF BOSNIA AND HERZEGOVINA (EPIDEMIOLOGICAL AND HEALTH SERVICES).UPON ENTERING THE TERRITORY OF BOSNIA AND HERZEGOVINA, DIPLOMATIC-CONSULAR STAFF MUST POSSESS AND PRESENT DIPLOMATIC CARD OF THE MINISTRY OF FOREIGN AFFAIRS OF BOSNIA AND HERZEGOVINA (TYPE D,MO,K,S,PO,PK,PP) AND A VALID PASSPORT.
- -THIS MEASURE IS NOT APPLICABLE TO MEDICAL STAFF ENTERING BOSNIA AND HERZEGOVINA FOR PROFFESIONAL ENGAGEMENT.
- THIS MEASURE IS NOT APPLICABLE TO PERSONS REQUIRING URGENT MEDICAL TREATEMENT .
- -THIS MEASURE IS NOT APPLICABLE TO MEMBERS OF MILITARY FORCES OF NATO STATES AND OTHER STATES WHICH PARTICIPATE IN THE PARTNERSHIP FOR PEACE, NATO HQ MEMBERS AND EUFOR IN BOSNIA AND HERZEGOVINA.
 -THIS MEASURE IS NOT APPLICABLE TO HEADS OF STATE AND MEMBERS OF THEIR DELEGATIONS WHOSE ARRIVAL AND DEPARTURE HAVE BEEN ANNOUNCED TO THE BIH BORDER POLICE THROUGH DIPLOMATIC CHANNELS OR THROUGH
- -THIS MEASURE IS NOT APPLICABLE FOR TRANSIT OF FOREIGN CITIZENS TO THEIR COUNTRY OF RESIDENCE, WITHOUT STAY ON TERRITORY OF BIH.
- -THIS MEASURE IS NOT APPLICABLE TO PASSENGERS RESIDING OR

PROTOCOLS OF THE COMPETENT BIH AUTHORITY .

TEMPORARILY RESIDING IN BOSNIA AND HERZEGOVINA. SUCH PERSONS WILL BE ALLOWED TO ENTER BOSNIA AND HERZEGOVINA, SUBJECT TO MANDATORY REPORTING BY THE SANITARY INSPECTOR AND PLACED UNDER MEDICAL SUPERVISION, WHICH WILL RESULT IN THE ISSUE OF AN APPROPRIATE DOCUMENT.

-THE DECISION ON THE ISOLATION OBLIGATION, FOR A PERIOD OF 14 DAYS, WILL BE ISSUED TO ALL PASSENGERS WHO ARE CITIZENS OF BOSNIA AND HERZEGOVINA AND PASSENGERS WHO HAVE PERMANENT OR TEMPORARY RESIDENCE IN BOSNIA AND HERZEGOVINA.

-ALL SANITATION AT AIRPORTS IS IMPLEMENTED IN ACCORDANCE WITH THE DECISIONS OF THE ENTITY MINISTRIES OF HEALTH.
