COVID 19: FLIGHT RESTRICTIONS

E) ACCORDING TO DECISION OF COUNCIL OF MINISTERS OF BOSNIA AND HERZEGOVINA IN ORDER TO PREVENT THE ENTRANCE AND SPREADING OF INFECTIOUS DISEASES INTO THE TERRITORY OF BOSNIA AND HERZEGOVINA, INTERNATIONAL BORDER CROSSINGS ON INTERNATIONAL AIRPORTS SARAJEVO (LQSA), MOSTAR (LQMO), BANJA LUKA (LQBK) AND TUZLA (LQTZ) ARE TEMPORARY CLOSED FOR TRANSPORT OF PASSENGERS.

ALL LANDINGS TO AND TAKE-OFFS FROM AIRPORTS IN BOSNIA AND HERZEGOVINA ARE PROHIBITED FOR AIRCRAFT CARRYING ON THE INTERNATIONAL PASSENGER AIR TRANSPORT.

THIS MEASURE IS NOT APPLICABLE TO FLIGHTS FOR:

1. THE TRANSPORT OF GOODS AND MAIL,
2. SEARCH AND RESCUE,
3. FLIGHTS FOR HUMANITARIAN PURPOSES,
4. URGENT MEDICAL TRANSPORT,
5. TECHNICAL LANDING AND POSITIONING OF AIRCRAFT ENTERED IN THE AIRCRAFT REGISTER OF BOSNIA AND HERZEGOVINA,
6. EMERGENCY LANDINGS,
7. FLIGHT CALIBRATION,
8. TECHNICAL LANDINGS WITHOUT DISEMBARKING PASSENGERS
9. LANDINGS AND TAKE-OFFS OF STATE AIRCRAFT AND
10. SPECIAL PURPOSE FLIGHTS.

DEPENDING ON THE EPIDEMIOLOGICAL SITUATION, OTHER EXCEPTIONS MAY BE PROVIDED BY THE DECISION OF COUNCIL OF MINISTERS OF BOSNIA AND HERZEGOVINA.

THE OPERATER THAT HAS COMMENCED THE FLIGHT PRIOR TO THE ENTRY INTO FORCE OF THIS PROHIBITION, AND HAS LANDED TO DESTINATION AIRPORT PRIOR OR UPON ENTRY INTO FORCE OF THIS PROHIBITION, SHALL BE ALLOWED TO PERFORM THE OUTBOUND FLIGHT TO ITS BASE/DEPARTURE AIRPORT.

PERSONS INVOLVED IN AIR TRANSPORT SHOULD COMPLY WITH ALL INSTRUCTIONS AND ORDERS OF THE COMPETENT AUTHORITIES IN BOSNIA AND HERZEGOVINA (EPIDEMIOLOGICAL AND HEALTH SERVICES).

NOTE: Briefing does not include any obsolete NOTAM older than 95 days.
