ALL PASSENGERS, CREW MEMBERS AND OPERATIONAL STAFF ARRIVING TO E) BOSNIA AND HERZEGOVINA BY AIRCRAFT MUST COMPLETE A PUBLIC HEALTH PASSENGER LOCATOR FORM (PLF). ALL PLFS MUST BE COLLECTED BY THE CREW, CHECKED AND HANDED OVER TO THE RAMP AGENT UPON LANDING. ALL AIRLINE OPERATORS ARRIVING IN BOSNIA AND HERZEGOVINA ARE

REQUIRED TO INFORM THEIR PASSENGERS BEFORE BOARDING THE AIRCRAFT WITH FOLLOWING INFORMATION: - IT IS FORBIDDEN TO ENTER FOREIGN NATIONALS ENTERING BOSNIA AND

HERZEGOVINA FROM AREAS WITH INTENSIVE TRANSMISSION OF CORONAVIRUS, ESPECIALLY FROM THE PROVINCES OF THE PRC (WUHAN), SOUTH KOREA, JAPAN, ITALY, IRAN, FRANCE, ROMANIA, GERMANY, AUSTRIA, SPAIN , SWITZERLAND AND BELGIUM. A FOREIGNER MAY ENTER BOSNIA AND HERZEGOVINA ONLY WITH A VALID PASSPORT. THIS MEASURE IS NOT APPLICABLE TO THE AIRCRAFT CREW AND CABIN CREW WHOSE FINAL DESTINATION IS BOSNIA AND HERZEGOVINA. THIS MEASURE IS NOT APPLICABLE TO DIPLOMATIC - CONSULAR STAFF ACCREDITED (RESIDENT) IN BOSNIA AND HERZEGOVINA, WITH THE OBLIGATION TO COMPLY TO ALL INSTRUCTIONS AND ORDERS OF THE COMPETENT AUTHORITIES OF BOSNIA AND HERZEGOVINA (EPIDEMIOLOGICAL AND HEALTH SERVICES). UPON ENTERING THE TERRITORY OF BOSNIA AND HERZEGOVINA, DIPLOMATIC-CONSULAR STAFF MUST POSSESS AND PRESENT DIPLOMATIC CARD OF THE MINISTRY OF FOREIGN AFFAIRS OF BOSNIA AND HERZEGOVINA (TYPE 'D', 'MO', 'K', 'S', 'PO', 'PK', 'PP') AND A VALID PASSPORT. -IN ACCORDANCE WITH THE LAW ON FOREIGNERS, THE DECISION ON REFUSAL OF ENTRY INTO BOSNIA AND HERZEGOVINA WILL BE DELIVERED TO ALL PASSENGERS COMING FROM THESE COUNTRIES. THIS DOES NOT APPLY TO TRAVELERS RESIDING OR TEMPORARILY RESIDING IN BOSNIA AND HERZEGOVINA. SUCH PERSONS WILL BE ALLOWED TO ENTER BOSNIA AND HERZEGOVINA, SUBJECT TO MANDATORY REPORTING BY THE SANITARY INSPECTOR AND PLACED UNDER MEDICAL SUPERVISION, WHICH WILL RESULT IN THE ISSUE OF AN APPROPRIATE DOCUMENT. -THE DECISION ON THE ISOLATION OBLIGATION, FOR A PERIOD OF 14 DAYS, WILL BE ISSUED TO ALL PASSENGERS WHO ARE CITIZENS OF BOSNIA AND HERZEGOVINA AND PASSENGERS WHO HAVE PERMANENT OR TEMPORARY RESIDENCE IN BOSNIA AND HERZEGOVINA. FOURTEEN (14) DAYS WILL BE COUNTED FROM THE LAST DAY OF STAY IN THE INFECTED COUNTRY / TERRITORY. -ALL SANITATION AT AIRPORTS IS IMPLEMENTED IN ACCORDANCE WITH THE

DECISIONS OF THE ENTITY MINISTRIES OF HEALTH. NOTE: Briefing does not include any obsolete NOTAM older than 95 days.
