RESIDENCE, WITHOUT RETENTION ON THE TERRITORY OF BOSNIA AND HERZEGOVINA, - MINORS WHOSE PARENT IS A CITIZEN OF BOSNIA AND HERZEGOVINA, AS WELL AS A FOREIGN CITIZEN WHO IS THE SPOUSE OF A CITIZEN OF BOSNIA AND HERZEGOVINA, - FOREIGN CITIZENS ARE OBLIGED TO FOLLOW AND RESPECT ALL INSTRUCTIONS AND ORDERS OF THE COMPETENT AUTHORITIES OF BOSNIA AND HERZEGOVINA, EPIDEMIOLOGICAL AND HEALTH SERVICES.
